1 THE AGREEMENT:

- BY INSTALLING AND/OR USING STUDIOH, YOU AGREE TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS EULA. If you do not so agree, do not install or use StudioH.

2 SOFTWARE PRODUCT LICENSE:

- WRH is distributing this free version of StudioH for personal use and educational purposes. You are NOT permitted to sell or otherwise profit from the distribution of StudioH to any other party. It may be distributed freely on any website or through any other distribution mechanism, as long as no part of it is changed in any way. I.e. provided that each copy shall be a true and complete copy, including all copyright and trademark notices (see below), and shall be accompanied by a copy of this EULA.
- StudioH (and its peripherals) is licensed as a single product. You may install and use an unlimited number of copies of StudioH.
- Nothing in this EULA shall give to the user or any other person any right to access or use the source code or constitute any license of the source code.
